


Flag Pole Speakers 9 **Gutter Outlet TOWER ROOF PLAN**

NICEIC Approved Contractor to disconnect existing speakers and make safe any associated electrical cables. Speakers to be stored safely in a dry place for possible reinstatement following completion of the works (SoW item 3.2)

The tower roof is accessed via the turret stair located within the north-east corner of the tower. The tower roof is surmounted with a Westmorland slate finished pyramidal roof, rising to an obelisk finial. The hips are slate mitred over lead soakers. The roof falls to asphalt lined parapet gutter with duck boards, which discharges to a single outlet at the eastern end of the south wall. The lightning conductor tape drops down the west side of the tower roof obelisk and connects to a perimeter tape which runs around the internal face of the parapet. The remains of a former flagpole are evident at the northern end of the west slope. Two load speakers are located within the north-east corner. Bracket fixed at the northern end of the western parapet wall is a glass fibre flagpole (SoW item 3.1)

Carefully disconnect lightning conductor as necessary to facilitate the works (SoW item 3.3)

General Notes:

- 1 All finishes disturbed and all damage caused resulting from the works is to be made good.
- 2 This drawing is to be read in conjunction with Drawing Nos issued with the prefix 1065/ and any specification of materials and works together with any accompanying schedules that may be issued.
